At the October 4, 2023, Board of Supervisors Regular Meeting, authorization was given to sell the 1999 Mack Tandem Axle Dump Truck through the Muncibid online auction. This item was publicly advertised and placed for sale on Muncibid.com with bidding ending today at 1:30 pm.

The attached auction report details the bidding activity including the winning bid from Donald Williams of Tunkhannock Township in the amount of \$21,800.00. I believe this amount to be more than reasonable for a 24-year-old truck that has been a workhorse of the fleet for both winter operations and for projects. We purchased this truck from Hatfield Township back in 2005 for \$65,000 and have had the use of the truck for the last 18 years at an average annual capital cost of \$2,400.

Therefore, it is my recommendation that the Board of Supervisors award the sale of the 1999 Mack Tandem Axle Dump Truck with Plow & Spreader to Donald Williams/Tunkhannock Township in the amount of \$21,800.00.
