

#### **OPEN SPACE GUIDELINES**

Do not deposit grass cuttings, rocks, trash, or other debris on Township open space land or in the streams, as they may injure Public Works crews when they maintain those properties.

These areas are for the enjoyment of all residents and any person found dumping or violating these regulations shall be subject to a fine. Please contact the Township office or police department if you see any abuse of Township open space.

Residents are not permitted to plant trees, or place trailers, sheds, boats, or fences, on township open space. (Park Rules and Regulations Chapter 117, Article 1)

Residents may obtain free gardening permits from the township to plant annuals or mow the grass within the township's open space. However, no mowing permits will be issued in the township riparian buffer zone. Riparian buffers, or "no-mow zones," protect the water quality of our streams and prevent erosion.
